## Tournament information and regulations

1. This Tournament is sanctioned by Tennis ACT and approved by ITF and TSA and shall be conducted in accordance with the laws of the game adopted by ITF and Tennis Australia.
2. The Referee shall be the final authority in any dispute in respect to the Rules of Tennis, Tournament Regulations, the Code of Conduct, and the Dress Regulations. The Referee in consultation with the Tournament Director shall also make decisions in respect to court conditions and extreme weather conditions. In any match that is postponed or discontinued, it shall be resumed from the point at which it stopped, at such time and place as determined by the Tournament Director.
3. Should any dispute arise on matters not included in the conditions, and not left specifically to the Referee, the matter shall be referred to the Tournament Director whose decision shall be final.
4. Refer to 'Notes' at the listing of events to ascertain the options available and event entry fees. Doubles competitors are expected to enter with partners. If a partner is not nominated, the Tournament Committee will endeavour to locate one but will not guarantee to do so. Partners as allocated must be accepted.
5. **Players entering IPIN events are required to enter online at [www.itftennis.com/ipin](http://www.itftennis.com/ipin) and [www.92computing.com.au](http://www.92computing.com.au). These players must enter BOTH Websites**
6. **Players entering NON –IPIN events are only required to enter online at [www.92computing.com.au](http://www.92computing.com.au).**
7. Competitors must be over the Event age as at 31 December 2020.
8. Each competitor **MUST** submit a separate electronic entry. **No entry will be accepted unless accompanied by entry fees.** Telephone/Facsimile/ E-mail entries will not be accepted. Late entries will not be accepted. No refunds will be given once the draws have been made.
9. **PAYMENTS:** Entries close on Tuesday, 31 March for IPIN Events and Monday 6 April for NON-IPIN Events. Entry fees in full must accompany the entry. Payments online can be made with Visa, MasterCard or Paypal. When entering online at [www.92computing.com.au](http://www.92computing.com.au) if you request to pay via a direct banking deposit, banking details will be emailed to you in your entry confirmation email. Payment by cheque is discouraged, but if you have to pay by cheque please make your cheque payable to 92 COMPUTING and post to: P O Box 362, Hay, NSW, 2711.
10. Championship Events 1-21 will be conducted as 'Knock-Out' events and shall be the best of 3 tie-breaker sets. A rest period, not exceeding 10 minutes, maybe taken at the end of the second set.
11. Championship Events 22-51 will be conducted as 'Knock-Out' events and shall be two tie-break sets and a Match tie-break (10 points)
12. NON-IPIN Round robins 52-86 will be conducted as Round Robin events. The number of games played per match will be determined by the number of entries in this event. These events may be played on synthetic grass, hard courts or clay courts.
13. The Seniors ITF tie-breaker rule will be used during the tournament, play one point and change ends and then change after every four points.
14. Should entries in the IPIN events be fewer than 8, the Tournament Committee may combine that event with the next age group or play it as a round robin event.
15. All first round losers are eligible for another match. Consolation events for players losing their first round singles matches will be conducted to provide the 2<sup>nd</sup> match but is dependent upon player entries. Doubles /Mixed pairs losing their first round match are eligible to play in the following days NON-IPIN round robin events. Byes are not deemed "a match", but Walkovers and Forfeits are deemed matches. **It is the responsibility of the player to enter the Consolation and NON-IPIN events**
16. Prize money will be awarded to winners and runner-ups in events having four (4) or more competitors. In events having less than four (4) competitors only winners will receive prize money.
17. Competitors should note late withdrawals may incur a ITF points penalty (refer 2018 ITF Seniors Regulations)
18. The time draw will be on the ITF website. If made necessary by weather or other causes, some matches may be played under lights. It is the player's responsibility to check the draw, ascertain his/her time for each match and be ready to play at least fifteen (15) minutes before his/her scheduled time to play, irrespective of weather conditions.
19. Regulation Tennis attire must be worn. Shoes with barred, studded or ripple soles will not be permitted.
20. Dunlop tennis balls will be used exclusively for the tournament.

## Terms and conditions of entry

1. The tournament specified on the Player Entry Form (Tournament) is sanctioned by the International Tennis Federation (ITF) and approved by Tennis Australia (TA) and managed and administered by Tennis Seniors Australia (TSA). The tournament will be run by the Tournament Committee.
2. By submitting a Player Entry Form for the Tournament, each player agrees to be bound by:
  - i. these Terms and Conditions
  - ii. the Tournament Information and Regulations including the eligibility requirements , and
  - iii. the Rules of Tennis as approved by the ITF, the ITF Seniors Circuit Regulations and TA's national policies including, without limitation, the Uniform Tennis Anti-Corruption Program, the TA Code of Behaviour (including its reference to spectator behaviour and interference), the TA Member Protection Policy and the TA Anti-Doping Policy (which may be obtained at <http://www.tennis.com.au/about-tennis-australia/reports-and-policies/policies>).
3. If there are any inconsistencies among the above documents, these Terms and Conditions will prevail.
4. Each player wishing to enter the Tournament must submit their Player Entry Form together with their ITF IPIN (if applicable) and the relevant Tournament fees in accordance with the details set out in the Player Entry Form. To be eligible to enter the Tournament, each player must be 35 or older as at 31 December in the year the Tournament is held.
5. Non-Australian residents:
  - i. must ensure that they satisfy all Australian Visa entry requirements in order to participate in the Tournament.
  - ii. who have a current MYTENNIS ID are covered by the Group Personal Accident Insurance policy but only while they are in Australia
  - iii. who do not have a current MYTENNIS ID are not covered by the Group Personal Accident Insurance.
6. Therefore all non-resident players should take responsibility for their own personal injury, medical and travel insurance arrangements.
7. By entering the Tournament, each player declares that they are medically and physically fit and able to participate in the Tournament. A player must immediately notify TSA of any change to their medical condition, fitness or ability to participate. Each player acknowledges that TSA will rely upon this declaration as evidence of that player's fitness and ability to participate in the Tournament.
8. Each player authorises representatives of TSA and TA to use and disclose the medical information provided on their Player Registration Form to obtain any medical assistance, treatment and transport for them as deemed reasonably necessary by TSA or TA. Each player consents to any such medical treatment and/or transportation and acknowledges and agrees that they will be responsible for any costs associated with any such medical treatment and/or transportation.
9. Each player acknowledges that TSA and TA require the information requested in the Player Entry Form and other personal information collected, obtained or derived by TSA and TA to administer player registration. Each player acknowledges that their personal information will only be used for this purpose and related or similar purposes which can reasonably be expected (including the provision of player and associated services). Each player consents to TSA and TA's use of their personal information in accordance with TA's privacy policy located at <http://www.tennis.com.au/privacy>.
10. By entering the Tournament each player consents to the ITF, TSA and TA recording and photographing their participation in the Tournament. Each player agrees that any such photographs, electronic images, sound recordings or video footage may be used by the ITF, TSA and TA, perpetually in resources and reports, or promotional, advertising or marketing materials, without any further notice or payment to the player.
11. The Tennis Officials Australia Tournament Referee (the Referee) will act as final authority in relation to all matters arising that require immediate resolution during the Tournament. No protests will be accepted for on-court or result issues. Should a player wish to dispute any other matter relating to the Tournament, including any question arising from the interpretation or construction of these Terms and Conditions, the notice of dispute must be received in writing by the Tournament Committee no later than 5pm on the next business day following the Tournament. The Tournament Committee must adjudicate upon any dispute referred to it for determination within fourteen days of the date of request for such adjudication by any party.

***Any dispute relating to the Terms and Conditions will be dealt with in accordance with the laws of the State of Victoria, and each player agrees to submit to the exclusive jurisdiction of the courts of Victoria.***

- IPIN players not drawn for doubles/mixed on the Friday can enter the NON-IPIN Friday events by phoning a late entry to the Tournament Director by mid-day Thursday.
- In normal circumstances the IPIN events will commence with singles at 8:30 each morning with the doubles and mixed following.
